In addition to public and private sector planning work, Courtenay is involved with many civic and volunteer efforts, including public community boards and non-profit organizations. Mercer is a sought after speaker and thought leader in redevelopment, downtown revitalization, bike/ped safety, state and regional planning policy, and equitable community engagement approaches.

Transportation Plan, Essex County, NJ

Managed the community and stakeholder engagement process, including strategic efforts to engage priority-equity communities. Services included coordinating and facilitating a Stakeholder Advisory Committee, focus groups, and public open houses, as well as a multilingual survey and mapping tool, social media, and targeted outreach coordination with organizations representing vulnerable populations. Also coordinated several pop-up outreach events, including two with tactical urbanism demonstration project installations.

Rt 9 Corridor TOD Plan, Middlesex & Monmouth Counties, NJ

Coordinating stakeholder outreach efforts, including Municipal Advisory Committees, a State and Regional Advisory Committee, focus groups, a survey, virtual open houses, and translation services. Also provided technical support identifying existing and anticipated state and regional plans, projects, initiatives along the corridor, as well as programs and incentives that could enhance TOD efforts.

Culture & Heritage Long Range Plan, Somerset County, NJ
